DECLARATION BY IMPORTER OF ACCOMPANIED OR
UNACCOMPANIED EFFECTS

WARNINGS

1. Any person who makes or signs or causes to be made or signed any declaration relating to the Customs which is untrue in any material particular is liable to fines or imprisonment or both, and the goods to which the declaration relates may be liable to forfeiture (Articles 92 and 104 of Customs Code Law N. 94 (I) 2004).
2. In law most articles are liable, on being imported into Cyprus, to Customs duty. As a concession, some articles imported in baggage which are solely for the importer's personal use on first arrival and which are properly declared may be admitted free of this charge. It is a condition of this concession that the importer will not sell or otherwise dispose of the articles in Cyprus. The law provides that they shall be liable to forfeiture if this condition is not complied with Articles 96 and 104 of Customs Code Law N. 94 (I) 2004.

1. You should read the warnings above.
2. You must declare in the schedule overleaf the articles that you are importing.
3. In addition to the schedule, you must complete A. of the declaration below and any other part, which applies.

5. After completing the declaration and schedule you must sign the form.
