## Introduction

1. The Global Removal Management Service (GRMS) section, within Movement Support Services, manages the removals contract on behalf of the MOD. The contract is currently let to Agility Logistics

## Reason for DIN

- 2. Transit Insurance is reviewed on a regular basis within the removals industry and, as a result, the following list of items are prohibited for movement under the GRMS contract.
  - Cash or Credit Cards:
  - Ammunition (all kinds) and explosive (including fireworks and toy caps);
  - Firearms, including antique weapons, replica firearms, sporting weapons, air rifles including pistols and similar weapons, knives (including Kukri);
  - Dangerous or controlled drugs;
  - Inflammable materials, e.g. paints, dyes, matches, solid fuel, fireworks, methylated spirits;
  - Motor vehicles, motorcycles, mopeds, sit on mowers including parts or assemblies (one set of winter tyres are allowed, but must be clean and expectable for carriage);
  - Internal combustion engines or any part thereof, other than those of go-karts, small outboard motors or conventional motor mowers (these engines must be purged and certificated by their owner before being included in consignments);
  - Perishable foodstuffs, including frozen items;
  - Any foodstuffs going into the USA or Australia:

- Cocoa, coffee or pure soluble coffee or mixed extracts (To and from Germany limit of 10 Kgs);
- Any item which, if it escapes or leaks from its container, could contaminate yours or another consignment;
- Compressed gas and aerosol containers of all types, including gas table lighters, charged sub-aqua air bottles, gas bottles, charged company gas cookers/stoves, heaters and lamps, hairsprays etc;
- Corrosive substances e.g. acids, alkalis, wet cell batteries, (dry cell batteries USA only), articles containing mercury such as barometers, thermometers, compasses and skis with mercury tips;
- Hazardous items classed as irritant;
- Oxidising materials, e.g. bleaching agents, peroxides and potassium chlorate;
- Poisonous substances, including pesticides, insecticides and weed killers;
- Indecent or obscene articles and items including books, magazines, films, videotapes, DVDs, and computer discs;
- Animals or birds including reptiles and aquatic creatures (whether alive or stuffed);
- Items derived from rare or endangered species including certain furs, ivory and reptile leather and articles made from them;
- Currency or currency instruments, including counterfeit money;
- Jewellery, watches, passports, travel documents, deeds and other important personal papers;
- Medals;
- Bulbs, plants and parts thereof, including trees, certain logs and timber, shrubs, fruit, raw vegetables, potatoes, lettuce seeds, tomato seeds and peas for sowing;
- Heavily magnetised articles including high-density diving lights;
- Radio transceivers or portable electronic equipment including walkie-talkies, microphones, micro bugs, and car mobile transceivers not approved for use at the destination. Power packs and/or batteries must be removed);
- Animal fodder (hay and straw);
- Timber (wood shavings unless correctly approved) and pottery kilns;
- Any items associated with a personal business venture;
- Surfboards, body boards, canoes (unless within the maximum dimensions (see JSP 800));
- Concrete/terracotta/marble statues or similar items (that are above the maximum weight limit of 30 Kgs);
- Pianos, antique furniture and valuable paintings (except when packed and unpacked at the Customer's expense);
- Cigarettes, tobacco or tobacco products, and
- Wines, spirits, beer or other alcoholic drinks.
